An authorized adult acting on behalf of the parent or legal guardian must provide a notarized statement indicating they have been given the authority by the parent or legal guardian to be responsible for the minor during the event. The parent, legal guardian or authorized adult must remain present while the AMA member they are responsible for is at the event.

CONDITIONS of ACCEPTANCE -

- (a) AMA membership cards must be presented at each event or participant must join the AMA at the event.
- (b) All checks must be negotiable. Participants submitting non-negotiable (IE. insufficient funds or stop-payment) checks will be considered non-starters for that event and will not be accepted for subsequent events until the matter is resolved. Any bank charges incurred will be paid by the participant.

ENTRY-

- (a) Entry fee is \$60-USD each round. Minder fee is \$25-USD each round. ITS Youth fee is \$15-USD for one day; \$25 for two days
- (b) Late Entries may be made after the deadline dates. Late entry fee is \$100-USD /Rnd.; \$50-USD Minders /Rnd.; \$20-USD Youth /1 Rnd, \$35-USD/2 Rnds., & will be enforced.
- (c) Please send only one (1) check totaling the correct amount for all requested entries. DO NOT STAPLE CHECK to form!
